

Countryside Duck Derby – Rules and Regulations

1. The Countryside Duck Derby is produced by Countryside Support and Memory Center (producer), a charitable organization under section 501(c)(4) of the Internal Revenue Code, with a mission to provide diverse programs for individuals in the community who are faced with cancer, memory loss and end of life issues.
2. A minimum of 4,000 ducks will be entered in the race. Chances of winning depend on the total number of qualified entries.
3. All ducks entered are and shall remain property of Countryside. Once the ducks are launched, they are on their own. No attempt to free or interfere with any duck is permitted, unless deemed necessary by the race committee.
4. The Countryside Duck Derby will start at approximately 11:30 a.m. at Steamboat Park Causeway on June 21, 2025. The race course will be established by the race committee. Countryside reserves the right to postpone or reschedule the race or to determine the winners by random drawing in the event of inclement weather, Acts of God, or other circumstances beyond the Countryside's control.
5. A number will be on the bottom of each duck corresponding to the same ticket number. The individuals names associated as the place winning ducks, will be awarded prizes. Positive identification and ticket stub will be required to claim any prize(s). Winners in attendance will be awarded their prize, those not in attendance will be notified by phone to pick up prize at Countryside office location at 415 S. Crow St. Pierre, SD.
6. A copy of the rules and regulations, a list of prizes and, after the event, a list of prize winners can be viewed at www.countrysidesupport.com and Countryside Support – Pierre, SD Facebook page.
7. All paper tickets and online submissions must be completed in their entirety and funds received by a Countryside Duck Derby representative by Friday, June 20th at 6:00pm CT to be eligible to win any prizes. Online entries received after 6:00 p.m. on Friday, June 20th, and any entries purchased on race day are subject to the availability of ducks, and in the event the number of these entries exceeds the available number of ducks, these entrants will not be eligible to win any prizes. Entrants assume the risk of non-delivery of any entries to an authorized representative of Countryside.
8. Cash prizes. Any taxes and fees are the responsibility of the winner. By entering, the entrants release Countryside, its officers, directors, volunteers, staff, sponsors and other related entities from any and all liability with respect to the prizes. By entering, winners consent to the promotional use of their names and likenesses without any additional compensation.
9. A minimum donation of \$5.00 is requested. 7 free entries will be used for radio promotion of the event. Duck adaptations can be made in person with a designated adoption rep, at Countryside office or online platforms.
10. The winner of any Prize must be over 18 years of age and must pay any applicable sales tax or other fees associated with the prize. If the Prize winner is under the age of 18, a parent or guardian may claim the prize on their behalf. Winner need not be present to win.
11. Winners will be announced following the Countryside Duck Derby. Winners will also, where necessary, be notified by telephone. If a winner does not claim his/her prize within 30 days of race date, or if Countryside is

unable to contact a winner due to insufficient or illegible contact information, or if a winner is deemed ineligible to win a prize, Countryside will select a substitute winner by random drawing of entry tickets. All prizes will be awarded.

13. All decisions and interpretations of rules and regulations will be made by Countryside's Duck Derby Committee and its judgment is final.

14. In case of bad weather or unforeseen circumstances preventing the running of the race, ducks will be selected randomly and winners will be notified by telephone and posted social media and website.

15. This event is subject to all federal, state, and local laws and regulations and is void where prohibited by law.
